1 Whereas a resolution was passed in KKS General body meeting held on 27th December 2020 for holding of elections to KKS Executive Council (EC) and appointment of Election officer and an updated list of KKS members has been handed over to Election Officer now ; the elections will be conducted as per following schedule:-

2 The elections will be held as per the provisions of by-laws of KKS and Haryana Registration & Regulation of Societies Act/rules 2012. Accordingly following positions are open for nomination-

President-1: Vice president- 2: General secretary-1: Secretary-2: Treasurer-1 & Executive members- 14.

3 For the purpose of electing executive members, by laws of Kks provide for dividing Gurugram into well demarcated areas as constituencies and each such constituency shall elect executive members for representing that area in the EC. Thus, while office bearers i.e. President, VPs, Secretaries, GS, Treasures will be elected by general Body i.e. all life members, the executive members will be elected by life members residing in that particular constituency subject to a minimum of 10 members. The details of constituencies are- DLF ; Sushant lok; Palam Vihar (Ansals); New Palam Vihar; Ashok Vihar; Contiguous HUDA Sectors; & gated communities etc...

4 Kks by-laws provide for holding elections by show of hands or secret ballot as may be decided by RO. Keeping in view the concerns of pandemic and also for making the election process transparent and credible, voting will be held by secret ballot system.

5 The list of KKS members eligible to vote is available on Kks site and KKS Notice Board at temple land. List of members shall be made available to a member on payment of photocopy charges.

6 Any member whose name does not appear in the voter list may please contact Election officer.
