# MINUTES OF THE EXECUTIVE COUNCIL MEETING OF THE KASHYAP KASHMIR SABHA, GURUGRAM, FOR THE MONTH OF JULY 2025.HELD AT THE RESIDENCE OF SH H.L.KHER

The quorum being duly established, the meeting was called to order by the President. Sh H.L.Kher was requested to chair the meeting. The following agenda items were taken up for discussion:

## 1. Approval of Temple Construction Rates

The committee reviewed and unanimously approved the rates proposed in the earlier Temple Committee meeting. After evaluating quotations for the basement slab work, the contract was awarded to Shri Sumbly at a finalized cost of ₹12.50 lakhs.

The scope of work includes:

- Shuttering Work: Beam sides, beam bottom, and slab
- Steel Reinforcement: Rathi Steel for beams, slab, and staircase
- RCC Work (M25 Grade): For beams, 8-inch-thick slab, and staircase
- Brickwork (9"): Under the staircase
- Additional Work: Electrical conduit pipe related to the slab

\*The Executive body committee accepted the recommendation of temple committee to release the previous pending five lakhs of Sh Susheel Sumbli. It was also decided that his other previous bill of approximately ₹1.47 lakhs will also be released after the correction of that bill. The Executive body also recommended to hold 10% of amount for new work & contract for a period of one year as done earlier.

# 2. Submission of CA-Signed IT Returns & Documentation

The committee discussed the letter received from the District Registrar regarding the urgent submission of CA-signed IT returns and related documents for previous years.

The President requested Sh. Rakesh Kaul and Sh. R.S. Tiku to contact Sh. Wanchoo and Sh. J.N. Tiku to collect:

- Audit reports and balance sheets for FY 2019-20, 2020-21, 2021-22
- The letter submitted by Sh. J.N. Tiku to the IT Department, for condonation of the 2020-21 return. The GS also told members that he will contact Sh Rohit Dhar and explore chances of getting the required documents.

## 3. Security Arrangements for Temple Land

The General Secretary informed that CCTV cameras will soon be installed at the temple site. The cost of installation will be borne by the same individual who had earlier donated steel and shuttering material for the construction.

#### 4. KKS IT Return Filing for FY 2024-25

The Treasurer is coordinating with CA Sh. Manish Gupta for timely filing of the IT return for the financial year from 01.04.2024 to 31.03.2025.

#### 5. Planning for Independence Day Celebrations (15 August 2025)

The President proposed organizing a cultural programme in celebration of Independence Day, preferably on 15th August or during that week. Members unanimously supported the idea, recommending the event be conducted with minimal expenditure, given the current focus on building the Heritage Centre.

#### 6. Update on Gurgaon Directory

The President requested all members, including Sh. Ramesh Bhat Sr. and Sh. Satish Kher, to actively assist in collecting data for the Gurgaon Directory.

Additionally, Sh. Satish Kher was asked to provide the list of KKS life members who have been issued KKS ID cards, which will serve as the base for developing the directory.

## 7. Neel Nag - Upcoming Issue

Sh. Ashok Zutshi and Sh. Ajay Peer informed the committee that the next edition of the Neel Nag newsletter is nearly complete and will be released shortly.
